A diagnosis alone may not be sufficient to guide Residential Services and the LSE Disability and Wellbeing Service in assessing the case. For example, a statement of a diagnosis of 'Cerebral Palsy' does not indicate the severity or complexity of the condition as experienced by the student. Cerebral palsy is unique to the individual - it may not always impact noticeably upon a student's requirements for their living environment; however, in some instances the level of impairment is severe and it will have a significant impact.
